I have submitted my ACT/SAT test scores to CMC.

I understand the following requirements for participation in WUE:

- I must maintain enrollment with a minimum of 15 credit hours for each semester I attend (the minimum for summer semester is 6 credit hours).
- I must remain a permanent resident of my home WUE state, maintaining my driver's license in that state.
- I must maintain good academic standing with a cumulative GPA of 2.0 or higher.
- **In order to continue my WUE eligibility, I must register for the next semester during the early registration period** (summer excluded).
- **WUE students who do not maintain the minimum credit hours and minimum 2.0 GPA each semester attended will be placed on probation.** Students will have one additional semester to maintain minimum credits and increase GPA to 2.0. Failure to do so will result in suspension from WUE eligibility and/or Colorado Mountain College.
