Through this unique partnership of local government entities, K-12 school districts and non-profit partners in the shared nine-counties in CMC's service district, we are collectively having a positive impact on increasing concurrent enrollment, college counseling support and enrollment, credit loads per student and student persistence. Two shining examples are seen at two different CMC campuses, our Rifle campus and our Edwards campus. At our Rifle/West Garfield campus, taking advantage of a forced "cost-cutting" four-day school week at two K-12 school districts in that region, CMC has worked in partnership with those school districts to offer a fifth day of learning for students. As a result, in fiscal year 2018, 56 West Garfield County high school students graduated high school with a career-enhancing certificate from Colorado Mountain College in Early Childhood Education, Solar Installation, Welding, Culinary or Nursing via concurrent enrollment at CMC Rifle, thanks to donor support and strong community partnerships.
